INTRODUCTION

The Stephen P. Millikin Papers consist primarily of printed materials relating to the war experiences and community involvement of members of the Black Cap Veterans Group. Stephen Millikin started the group in 2002 for war veterans to unite and share their personal accounts. As the leader, he encouraged members to record their wartime experiences for posterity. Personal experiences are shared through typed reminiscences, transcripts of speeches, and resumes. The majority of the veterans served in World War II, while a few fought in Vietnam or Iraq. The collection also contains printed materials relating to events held by the Black Cap Veterans Group. Researchers interested in World War II, the experiences of veterans during and after war, or the Black Cap Veterans Group may find this collection useful.

Arrangement: This collection is organized into four series and arranged within series by document type and/or subject. The series are: **Black Cap Directory**, 2002-2005; **Black Cap Events**, 2003-2006; **Millikin, Stephen P.**, 1944-2006; and **War Reminiscences**, 1943-2006.

Provenance: This collection was donated by Stephen P. Millikin's wife, Sally, in November 2007 and assigned accession number 2007.41.1.

Processing: This collection was organized and the finding aid was prepared by intern Savannah Edwards in July 2019.

BIOGRAPHICAL NOTE

Stephen P. Millikin (1926-2007) was born to Treva and Perry C. Millikin in Richmond, Virginia. He grew up in Halifax, North Carolina and graduated from Weldon High School in 1943. After attending North Carolina State University for a semester, he dropped out to join the United States Navy. During World War II, he served at Seventh Fleet Headquarters on Leyte Gulf and aboard the USS *George A. Johnson*. He received seven campaign medals for his service and later joined the Naval Reserve.

After World War II, Millikin earned his bachelor's and law degrees from the University of North Carolina at Chapel Hill. He then moved to Greensboro to work as a trial attorney for Smith Moore LLP. During his law career, he received the Distinguished Service Award from the Greensboro Bar Association and became president of the University of North Carolina Law Alumni Association. He was a member of West Market United Methodist Church and active in

the American Heart Association, the Greensboro Country Club, the National Society of the Sons of the American Revolution, and the Veterans of Foreign Wars.

Millikin married Ruth Ann White in 1956, and the couple had three children, Leslie, Stephen P. Jr., and John. He and his first wife divorced in 1974, and he married Sally. In 2002, he founded the Black Cap Veterans Group to create a space for veterans to come together and discuss their war experiences. The group's activities include monthly breakfasts and ceremonies for Memorial Day and Veterans Day at Country Park. Millikin passed away in 2007, but the group continues to meet and is open to all war veterans.

Biographical Sources: The sources used to compile this biographical note include materials in the collection, Ancestry.com, and the obituary of Stephen P. Millikin (*News & Record*, October 31, 2007).

SCOPE & CONTENT NOTE

The types of materials in this collection include photographs, correspondence, and printed materials pertaining to the life of Stephen P. Millikin and members of the Black Cap Veterans Group. The majority of the collection focuses on the experiences of Black Cap members during World War II. Most materials are typed or printed, including war reminiscences, resumes, and newspaper clippings detailing war experiences, as well as transcripts and invitations to Black Cap meetings. Items that relate to the life of Stephen P. Millikin include an interview transcript, newspaper clippings, and personal reminiscences. Researchers interested in World War II, the experiences of veterans during and after war, or the Black Cap Veterans Group may find this collection useful.

SERIES DESCRIPTIONS

1. Black Cap Directory. 3 folders (3 items). 2002-2005.

The majority of this series consists of information sheets that Stephen P. Millikin collected from members of the Black Cap Veterans Group (1:2-3). Each sheet contains the member's name, address, telephone number, rank, dates served, current occupation, and an optional brief story from their time served. Some members shared additional information such as newspaper articles, resumes, and business cards. The series also contains a final copy of the directory provided to all members of the Black Cap Veterans Group (1:1). In addition to information gathered from the information sheets, the finalized directory includes transcripts of speeches and personal accounts.

2. Black Cap Events. 19 folders (ca. 70 items). 2003-2006.

This series consists of invitations, transcripts and pictures from events held or attended by the Black Cap Veterans Group. A highlight is the complete transcript of the Black Cap meeting on January 11, 2003 (2:2), which shows the structure of meetings and the papers handed out to those in attendance. Miscellaneous invitations to Black Cap Veterans Group meetings detail the

speakers and topics of the next meetings (2:1). Also included are handouts and transcripts from Memorial Day (2:10-11) and Veterans Day ceremonies (2:18-19), as well as photographs of Black Cap members (2:13-16).

3. Millikin, Stephen P. 6 folders (ca. 12 items). 1944-2006.

The materials in this series relate to the military and civilian life of Stephen P. Millikin. Of particular interest are papers Millikin gathered and titled "Random Thoughts and Beliefs" (3:4). They include Millikin's own personal account of World War II and documents he collected during his military and law careers. Also of note is a transcript of Kenneth R. Samuelson's interview of Millikin about his war experience and life after the war (3:1). Other items of importance focus on Millikin's civilian life, such as pictures of awards he received during his career as a lawyer (3:5).

4. War Reminiscences. 17 folders (ca. 21 items). 1943-2006.

The War Reminiscences series contains personal accounts, resumes, newspaper articles, and correspondence from members of the Black Cap Veterans Group. The majority of the series consists of World War II experiences (4:5-17), with a highlight being Bob Hites' detailed account of his experience fighting in Europe (4:11). Also of interest from World War II are copies of newspaper articles, pictures, and correspondence detailing Paul Hendren's experience serving in North Africa (4:10). The remainder of the reminiscences are from other wars, including Vietnam and Iraq (4:1-4).
